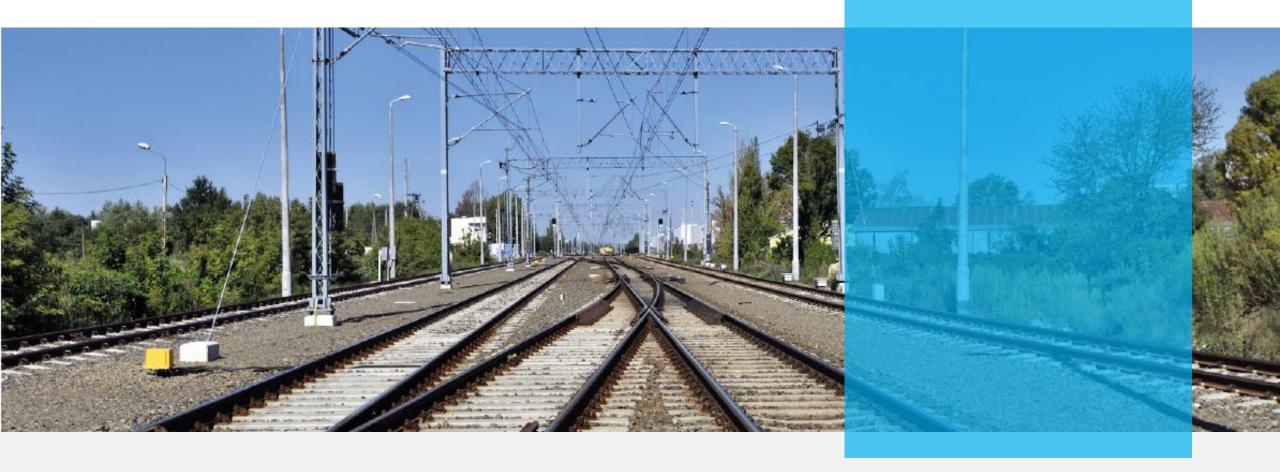

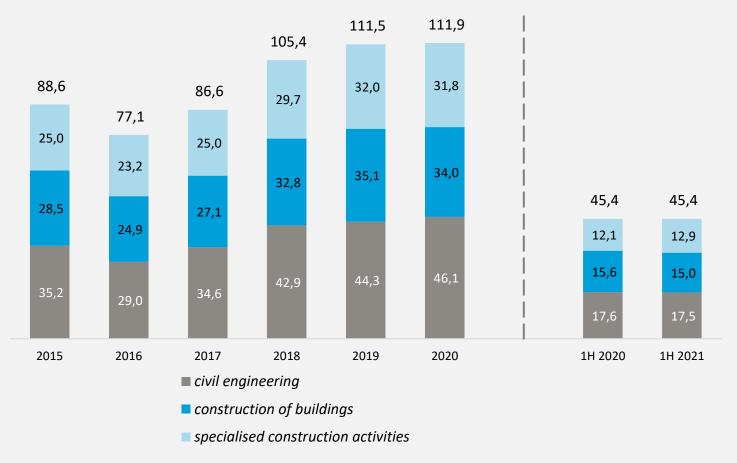

bn PLN



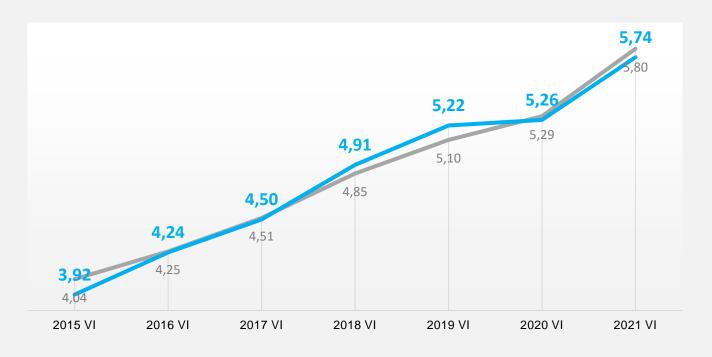
CONTRUCTION AND ASSEMBLY PRODUCTION MARKET

The domestic market of construction and assembly production in the first half of 2021 was the same level as in the corresponding period of 2020.

Despite the Covid-19 pandemic, the value of sales on the construction market at the end of 2020 reached a similar level as in 2019.

WAGES IN CONSTRUCTION SECTOR

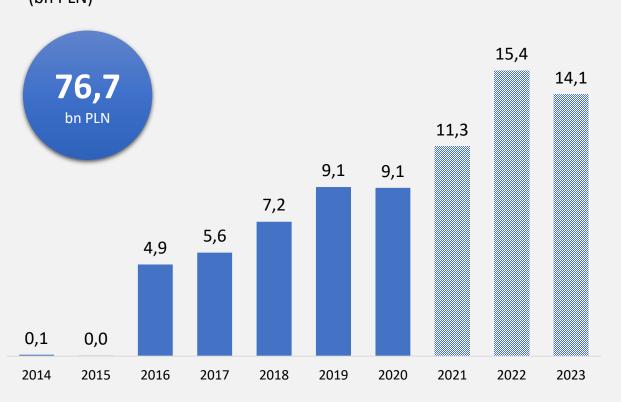
Wages and salaries in the construction industry have been systematically growing YoY in recent years.

In mid-2020, the trend was temporarily suspended due to the outbreak of the Covid-19 pandemic. At the end of the 1H of 2021, the increase in the average monthly gross salary returned to the growth path resulting from the pre-pandemic trend.

The National Railway Program until 2023 (KPK) is a long-term government program implementing national development strategies for the construction and modernization of railway infrastructure. According to the last update from July 2021, the planned **expenditure for the years 2021-2023** will amount to 40,7 bnPLN.

Other Railway Development Programs:

- 1. Aid in financing the costs of managing railway infrastructure, including maintenance and repairs until 2023 **23.8 bnPLN**
- 2. Railway Stations Investments Program for 2016 2023 1.6 bnPLN
- 3. Program for Supplementing the Local and Regional Railway Infrastructure ,Railway +' until 2028 **6.6 bnPLN**
- 4. The government program for the construction or modernization of railway stops for the years 2021–2025 **1 bnPLN**

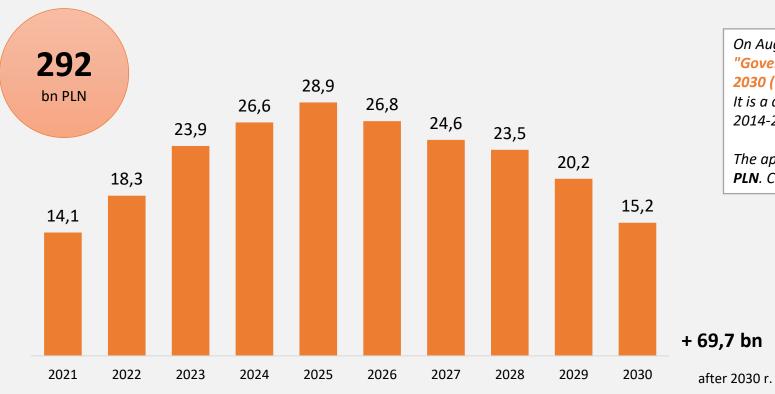
The railway component within the CPK project – it assumes the **construction of 1,800 km of new lines by 2034**. As part of the project, 12 new railway routes will be built, including 10 so-called "spokes" leading to the new "Solidarity Airport' and Warsaw. The first construction works are to start in 2023.

On August 9, 2021, the government announced the project of the "Government Program for the Construction of National Roads until 2030 (with a perspective until 2033)".

It is a continuation of the National Road Construction Program for 2014-2023 (with a perspective until 2025) from September 8, 2015.

The approximate total value of the program amounts to **292 bilion PLN**. Currently the project is under public consultations.

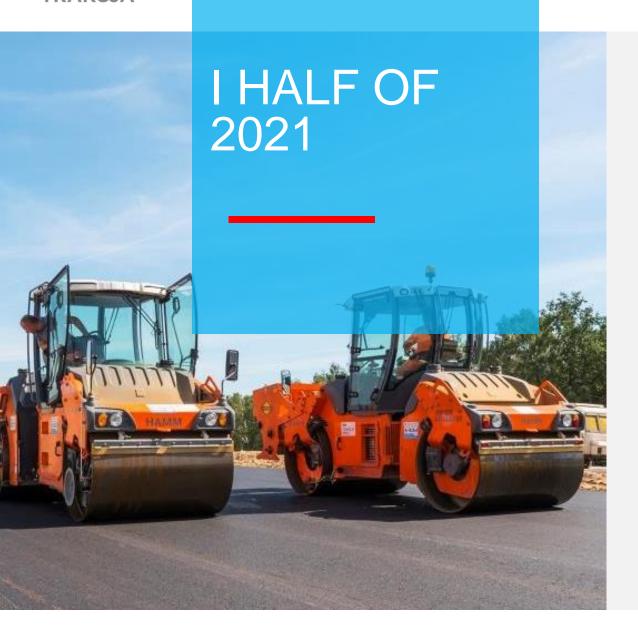

In H1 2021, the Trakcja Group's sales revenues were at PLN 534 million and decreased by 4% as compared to the corresponding period of the preceding year. The Group's gross profit on sales for H1 2021 was at PLN 8,6 million and was lower by PLN 9,5 million in comparison to H1 2020. In the analysed period, the gross profit margin on sales was -1,6% and by 1,7 p.p. lower than in the corresponding period of 2020.

The Group ended H1 2021 with a loss on operations amounting to PLN 34,5 million, which means an increase of the loss on operations by PLN 4,5 million in comparison to the comparable period of the preceding year.

The Group ended H1 2021 with a net loss of PLN 37,6 milion, in the corresponding period of the preceding year, the Group incurred a net loss of PLN 38,2 million.

EBITDA for H1 2021 was at PLN -15,6 milion, which means decrease by PLN 4,5 million in comparison to H1 2020. In H1 2021, the EBITDA margin reached -2,9%, meaning a drop by 0,9 p.p in comparison to H1 2020.

As at June 30, 2021, the balance sheet total of Trakcja Group was at PLN 1 423 million and decreased by PLN 54,5 million i.e. 4% in comparison with its balance as at the end of 2020.

As at June 30, 2021, non-current assets were at PLN 566,6 million and decreased by PLN 14,7 million. Current assets were at PLN 856,6 million and decreased by PLN 39,8 million in comparison with its balance as at the end of 2020.

In H1 2021, the total equity decreased by PLN 48 million, in comparison with the balance as at December 31, 2020 and reached PLN 289,2 million as at June 30, 2021.

As at June 30, 2021, long-term liabilities were at PLN 397,3 million, meaning an increase by 17%. Short-term liabilities reached PLN 736,8 million and decreased by PLN 63 million in comparison with the balance as at the end of the preceding year.

In H1 2021, Trakcja S.A. generated sales revenues at PLN 317,4 million, which increased by 0,5% as compared to the corresponding period of the preceding year.

In the analysed period, the gross profit margin on sales was -3,3% and decreased by 2,46 p.p. in comparison to the comparable period.

The Company's operating loss for the 6 months 2021 amounted to PLN 23,9 million, in comparison with a loss of PLN 18,1 million in H1 2020.

The Company's net loss for H1 2021 was at PLN 26,4 million and was lower by PLN 3,4 million than the result generated in H1 2020.

EBITDA for H1 2021 was at PLN -13,6 milion, which means decrease by PLN 5,5 million in comparison to H1 2020. In H1 2021, the EBITDA margin reached -4,3%, meaning a drop by 1,7 p.p in comparison to H1 2020.

As at June 30, 2021, the balance sheet total of Trakcja S.A. was at PLN 1 100 million and decreased by PLN 34,5 million in comparison with its balance as at the end of 2020.

The value of non-current assets as at June 30, 2021 amounted to PLN 614,9 million, and increased by 0,1% in comparison to the balance of non-current assets as at December 31, 2020. The Company's current assets decreased by PLN 35,3 million, meaning 6,8% in comparison with the balance as at December 31, 2020, and reached PLN 485,2 milion.

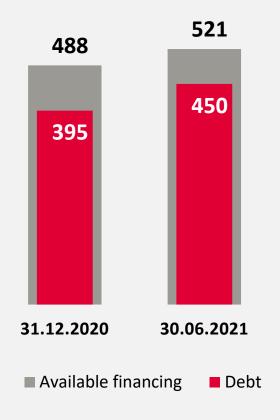
As at June 30, 2021, the Company's equity was at PLN 253,2 million and decreased by PLN 26,4 million, i.e. by 9,4%, in comparison with the balance as at December 31, 2020.

As at June 30, 2021, long-term liabilities reached PLN 384,7 million and increased by PLN 90,1 million, i.e. by 30,6% in comparison with the balance as at December 31, 2020. Short-term liabilities were at PLN 462,2 million and dropped by PLN 98,2 million, i.e. by 17,5%, in comparison with the balance as at the end of the previous year.

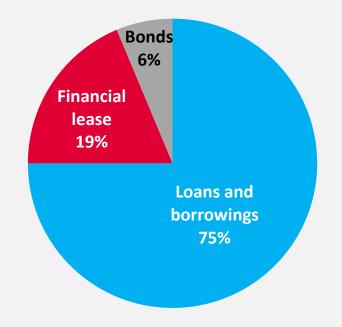

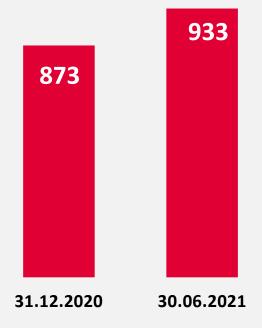
Available financing

Use of guarantee lines





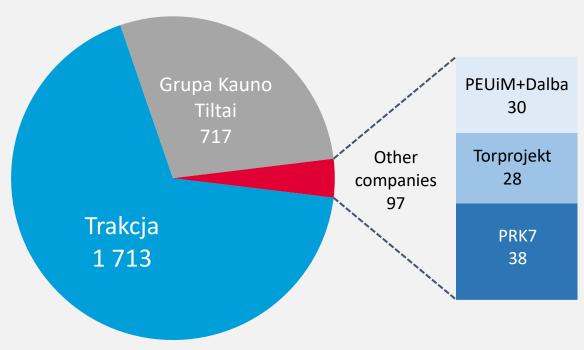

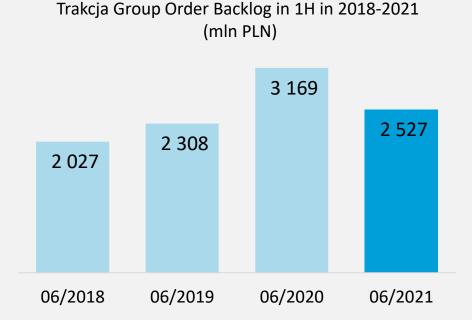


Order backlog of Trakcja Group as of 30.06.2021

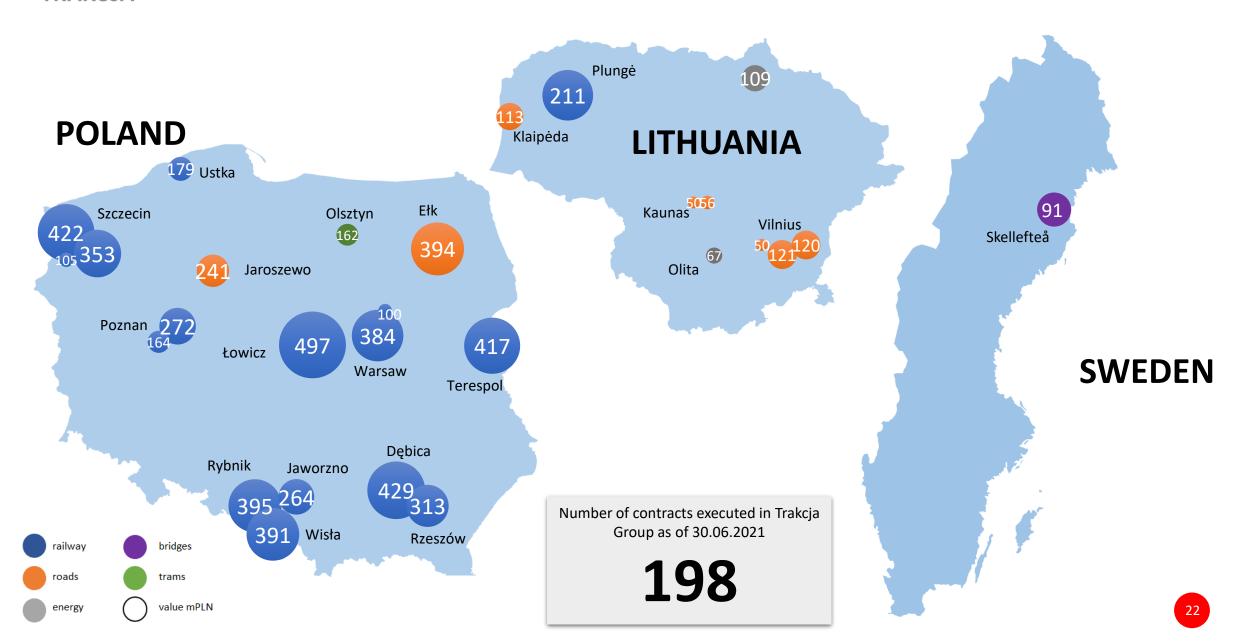








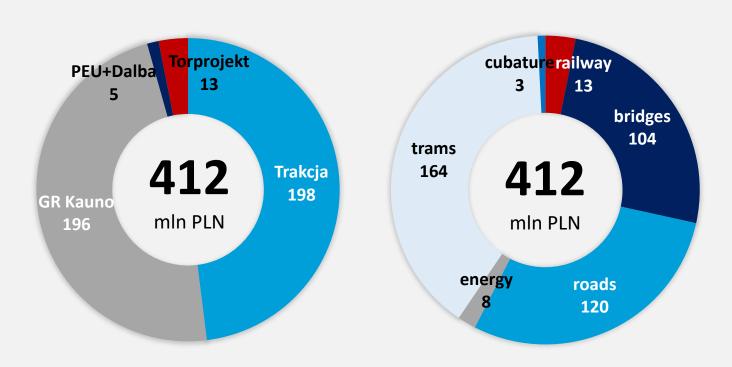
